## **2. Institutional Development Proposal (IDP)**

### **2.1 Executive Summary of the IDP**

Smt.V.R.Bhakta College of Education is affiliated to Indian Institute of Teacher Education, Gandhinagar. Our institute is located 20 km away from Surat city. Students from various classes of society are enrolled in the institution without any discrimination of caste, creed, religion, gender or socio-economic status. The vision of our institution is “To help society to fulfill its need of trained, hardworking, sincere and honest teacher”. For that the institution is keen to provide the sufficient technological infrastructure as well as skill and value based education” to the students studying in the institution.

#### **2.1.1 Curricular Aspects**

Smt.V.R.Bhakta College of Education is a college affiliated to Indian Institute of Teacher Education, Gandhinagar. It is incumbent that we follow the syllabus designed by “Board of Studies” (BOS) of Indian Institute of Teacher Education, Gandhinagar. Members of BOS have introduced Core & Elective Subjects besides CBCS and Semester system. The Core Subjects like four languages, psychology, perspective in education, curriculum development, pedagogy subjects, inclusive education, ICT in Education and measurement and evaluation are included which reflects global trends. To Enhancing professional capabilities in trainee’s courses introduce like reflective reading, Art in Education, Environmental Education, Yoga in Education, Guidance and Cancelling. In short our curriculum is upgraded, new and modern which will certainly

help our trainees to compete globally. Moreover, Value Education, ICT and Environment Education were introduced as Electives for in-depth study giving them separate identity although they were interwoven with some Core Courses. The system of Continuous Internal Evaluation (CIE) has been advised by the affiliating university. Practice teaching and internship components will be organised to develop better understanding of the theoretical concepts, principles and their applications and professional skills and competencies for effective teaching and learning. More over teacher educators of VRB are enthusiastic to apply new techniques of teaching learning for its transaction and for holistic development of the trainees.

### **2.1.2 Teaching Learning and Evaluation:**

A transparent online admission system based on merit is adopted by the institution for admission. The Government rules regarding reservation of seats in educational institution are strictly followed. The academic calendar prescribed by Dept. of Higher Education, Govt. of Gujarat and Indian Institute of Teacher Education is followed. Modern methods of teaching like presentation of papers, seminars, assignments, audio-visuals, internet, etc. are adopted to implement effective teaching-learning process. The trainees are divided in a group and each group is compelled to go to library every day and read books and collect important material for seminars, group discussions and assignment. Trainees are asked to collect elative additional information from the websites. Difficult units and statistics include peer group learning. Self-learning techniques instead of Spoon-feeding techniques should be applied. Co-curricular activities could be interwoven with the

course content or the syllabus. Moreover, before Micro & Macro Teaching sessions the principles mentioned above are exposed to the Trainees and discussed in depth with ample Demonstrations. Internship program is held for trainees in second year .During this they also experience of school administrative works. The college observes strict discipline in and out of the class to facilitate the smooth functioning. Internal evaluation of the students is carried out as per the rules of the university. Results of college students in university exam is 100%. It is shown in the table 1. There has been no instance of ragging, violence or gender harassment. Students of our institute participate in various sports and Co-curricular events organized by university. A wide range of co-curricular and extra- curricular activities are planned at the beginning of each academic year. VRB has been maintaining the spirit of Active and Real Learning applying variety of modes, approaches, and techniques of teaching through experimentation.




